RULES & REGULATIONS FOR ACCESS AND PARKING AT KAMEHAMEHA SCHOOLS MAUI

- The Kamehameha Schools Maui access pass must be affixed to the rearview mirror, visible to Kamehameha Schools Maui Security Officers.
- 2. When requested by a Security Officer, the driver of the vehicle will present for inspection a current vehicle operator's license, motor vehicle registration certificate and valid Hawaii no-fault insurance card.
- Vehicles left unattended without prior notification after normal school hours may be towed away at the expense of the owner.
- 4. Kamehameha Schools Maui reserves the right to amend the rules and regulations for entry to, access and parking on property at any time.
- 5. This agreement may be subject to cancellation at any time should you:
 - a. Fail to abide by posted traffic signs, to include speed limit and other traffic control measures, or any provisions of the Hawaii Traffic Code or County of Maui Traffic Code.
 - b. Fail to park in a designated parking stall.
 - c. Park in "No Parking" zones or fire lanes.
 - d. Park in "Handicapped" stalls without proper authentication or authorization by placard and positive identification card.
 - e. Fail to maintain a current vehicle operator's license, motor vehicle registration certificate, proof of no-fault insurance and State of Hawaii vehicle safety inspection sticker.
 - f. Fail to promptly report any change(s) in vehicle information to the Security Department.
- 6. Limitation of Liability: Access and parking on property is at the sole discretion of the owner/operator. Kamehameha Schools disclaims any responsibility for death or injury to the operator or occupant(s), damage to the vehicle(s) by collision, theft, fire, vandalism or act of nature. Further, Kamehameha Schools will not be responsible for consequential or indirect damages, and the owner/operator hereby agrees to hold harmless Kamehameha Schools, it's employees and/or it's agents, from any claim whatsoever, including attorney's fees.
- 7. Report(s) of Incidents: Property damage or personal injury should be reported to the Security Department at 808-572-4260 or 808-870-3365, as soon as practical after the incident.
- 8. Access Parking Passes are the property of Kamehameha Schools Maui. Changes in vehicle ownership, attendance or employment status at Kamehameha Schools Maui require that the pass be removed from vehicles and surrendered to the Security Department.
- Passes are good until the youngest child in the family graduates. Parents/Guardians and employees are responsible to inform the Security Department of any changes regarding vehicle registration information. Graduates and departing employees will return parking passes to the Security Department.
- 10. High School student-drivers may apply for a blue student pass through the High School Administrative Coordinator.
