NOTICE OF ANTICIPATED VACANCY; STIPULATION FOR APPOINTMENT OF A MASTER AND A TRUSTEE SCREENING COMMITTE

A. BACKGROUND

Petitioners ELLIOT KAWAIHO'OLANA MILLS (Chair of the Board of Trustees), ROBERT K.W.H. NOBRIGA, CRYSTAL KAUILANI ROSE, JENNIFER NOELANI GOODYEAR KA'ŌPUA, and MICHELLE KA'UHANE, the incumbent Trustees under the Will and of the Estate of Bernice Pauahi Bishop, Deceased, by and through their counsel, respectfully show as follows:

- 1. The term of Petitioner ROBERT K.W.H. NOBRIGA ("*Trustee Nobriga*") as a Trustee will expire on June 30, 2025, creating a vacancy on the Board of Trustees of the Kamehameha Schools. It is in the best interest of the Kamehameha Schools that the process for Selection of Trustee Nobriga's successor be commenced at this time.
 - 2. Article Fourteenth of the Will of Bernice Pauahi Bishop provides in part as follows:

 I further direct that the number of my said trustees shall be kept at five; and that vacancies shall be filled by the choice of a majority of the Justices of the Supreme Court
- 3. All five of the incumbent Justices of the Supreme Court of Hawai'i, acting in their individual capacities and not in their collective or official capacity as the Supreme Court of Hawai'i, have informed counsel for Petitioner that they decline to exercise the power to appoint trustees to the Board of Trustees of the Estate of Bernice Pauahi Bishop. A true and correct copy of the June 15, 2020, letter from Chief Justice Mark E. Recktenwald and Associate Justice Sabrina S. McKenna, and then Associate Justices Paula A. Nakayama and Richard W. Pollack, in their individual capacities declining to exercise their power to appoint trustees, is attached hereto as Exhibit A. A true and correct copy of the June 8, 2022, letter from Associate Justice Todd W. Eddins is attached hereto as Exhibit B. A true and correct copy of the January 23, 2024, letter from Associate Justice Vladimir P. Devens is attached hereto as Exhibit C. A true and correct copy of the February 7, 2024, letter from Associate Justice Lisa M. Ginoza is attached hereto as Exhibit D. Notice of these proceedings will also be delivered to each of the incumbent Justices of the Supreme Court of Hawai'i.
- 4. By the Order Granting Petition for the Establishment of a Procedure for Selection of Future Trustees filed herein on January 6, 2000 (the "January 6, 2000 Order"), this Court approved and adopted the Proposal For a Selection Process For Future Trustees presented in the

Master's Report on the Petition for the Establishment of a Procedure for Selection of Future Trustees filed August 5, 1999 filed herein on November 22, 1999 (the "1999 Master's Report").

- 5. The 1999 Master's Report and the January 6, 2000 Order contemplate a committee to assist the Court by identifying qualified individuals and selecting finalists for vacant trustee positions. Within ninety (90) days of the filing of a notice of anticipated vacancy, this Court is to constitute a committee comprised of a minimum of seven (7) "knowledgeable and informed persons, each of whom the Court finds to possess the integrity, probity, competence and disinterested status necessary to be qualified and serve as an independent and unconflicted Committee member." 1999 Master's Report at 27. Each committee member "shall be familiar with and sensitive to (1) the history and role of the Trust Estate relative to the Hawaiian community and the community at large, and (2) Pauahi's legacy and her vision for the future of Hawaiian children." Id. at 27–28. Each committee member "shall possess experience and insight into the operation and management of ... a large private educational institution; ... large financial institutions; or . . . large public charitable trusts or foundations." Id. at 28. The committee members are to be constituted as officers of the court akin to a court-appointed master or a Kokua Kanawai in accordance with Rules 28 and 113 of the Hawai'i Probate Rules. Id. Pursuant to Stipulation entered herein on March 21, 2000, the committee is to be known as the "Trustee Screening Committee".
- 6. By further Stipulation for Payment of Expenses Incurred by the Trustee Screening Committee; Exhibit "A"; Order filed herein on May 25, 2000 (the "May 25, 2000 Order"), reimbursement of certain expenses of the Trustee Screening Committee is authorized, upon and subject to the terms and conditions of the May 25, 2000 Order.

7. This Court has jurisdiction of the matters presented herein under Hawai'i Revised Statutes Sections 554D-201(c)(1), 554D-203(a) and 603-21.7(1)(C).

B. NOTICE OF ANTICIPATED VACANCY

Although the Court is currently considering the Trustees' Petition for Review of Trustee Selection Process and Trustee Terms filed May 10, 2022, and its ruling may ultimately affect the selection of Trustee Nobriga's successor, pursuant to the current process set forth in the 1999 Master's Report and the January 6, 2000 Order, Petitioners hereby give notice of the vacancy that will arise upon expiration of Trustee Nobriga's term.

C. <u>STIPULATION FOR APPOINTMENT OF A MASTER AND A TRUSTEE SCREENING COMMITTEE</u>

Petitioners and the Attorney General of the State of Hawai'i, as *parens patriae*, hereby stipulate and agree as follows:

1. That hearing of this Notice of Anticipated Vacancy; Stipulation for Appointment of a Master and a Trustee Screening Committee is waived.

2. That this Honorable Court:

- a) By its separate Order of Reference, appoint a Master to advise this Court in the premises;
- b) By its separate Order and in accordance with the provisions and requirements of the 1999 Master's Report and prior Orders of this Court, appoint a Trustee Screening Committee, authorizing and directing the Committee to proceed in accordance with the 1999 Master's Report, the January 6, 2000 Order and any supplemental orders of this Court in assisting this Court by identifying qualified individuals to succeed Trustee Nobriga and selecting finalists for that position; and

- c) Authorize reimbursement out of the Trust Estate of the Trustee Screening Committee's expenses of a consultant knowledgeable and experienced in hiring executive personnel and of other reasonable and necessary expenses in accordance with the May 25, 2000 Order.
- 3. That upon the Committee's filing of its final report of its selection of three finalists to succeed Trustee Nobriga, this Honorable Court set a date and time for hearing on the Committee's report and thereafter appoint one of the persons so selected to serve as a successor trustee under the Will and of the Estate of Bernice Pauahi Bishop, Deceased, for such term as this Court shall determine, upon and subject to the terms of the trust, applicable law and the orders of this Court; and
- 4. That nothing herein shall be deemed or construed as modifying, amending or changing in any respect the role and functions of the Trustee Screening Committee or the requirements applicable to that Committee as set forth in the prior Orders of this Court, including but not necessarily limited to the January 6, 2000 Order (and the 1999 Master's Report which it approved and adopted) and the May 25, 2000 Order.

Dear Ms. Griswold:

I respond to your letter dated March 16, 2022, which is addressed to me in my individual capacity and not in my official capacity as an Associate Justice of the Hawai'i Supreme Court. You ask that I "provide written confirmation that you intend to decline to exercise any power you may have as an individual to fill any vacancy that may be created at the end of Elliot Mills' term or any future vacancy on the Board of Trustees of the Estate of Bernice Pauahi Bishop." And if my position is otherwise, you ask that I "please let us know that as well."

Only my status as a Hawai'i Supreme Court justice triggered your request.

Canons 1, 2, and 3 of the Hawai'i Revised Code of Judicial Conduct guide judges' conduct. These time-honored canons require judges to both avoid impropriety and its appearance and to conduct their personal affairs to minimize the risk of conflict with the duties of judicial office. Given these canons, there is no ethical way for any justice – individually or in an official capacity – to appoint Bishop Estate trustees. We just can't do it. I must, therefore, decline your request.
